SCH Online* is available now and allows NESS Super participating employers to make payments to multiple funds (in addition to NESS Super) from a single secure website and is an integrated enhancement of NESS Super's EmployerAccess online payment facility. It is an efficient and easy way to comply with the Superstream requirements and take the stress out of paying into multiple super funds. Registration is quick via EmployerAccess. If you are not a participating employer of NESS Super, a clearing house service with your default fund can distribute contributions to NESS Super for employees that have completed this Choice of Super Fund Form.
